BOR RESOLUTION NO. 110, s. 2015

A RESOLUTION CONFIRMING THE NEW APPOINTMENTS OF NINE (9) ACADEMIC STAFF FROM THE EXTERNAL CAMPUSES ON CONTRACTUAL STATUS EFFECTIVE ON THE DATES INDICATED AND SUBJECT TO EXISTING RULES, REGULATIONS AND GUIDELINES GOVERNING SUCH APPOINTMENTS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437:

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board "to appoint, upon the recommendation of the President of the University, vice-presidents, deans, directors, heads of department, faculty members and other officials and employees of the University";

WHEREAS, the Visayas State University needs to hire qualified academic faculty to teach the different courses in the University;

WHEREAS, the College Deans through the Vice President for Academic Affairs have recommended their appointments as new contractual academic faculty;

WHEREAS, University Academic Personnel Board (APB) has gone over the qualifications of the appointees and the Human Resource Management and Development Office (HRMDO) has recommended to the University President the issuance of new appointments charged to Lump Sum appropriation of the following:
