A RESOLUTION APPROVING THE CONVERSION OF THE BACHELOR OF SCIENCE IN AGRICULTURAL DEVELOPMENT TO BACHELOR OF SCIENCE IN DEVELOPMENT EDUCATION

WHEREAS, Section 4, Paragraph (i) of R.A. 8292 empowers the Governing Board "to approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils as hereinafter provided";

WHEREAS, Paragraph (i) of Section 18 of CHED Memorandum No. 3, s. 2001 dated 21 January 2001 likewise stipulates, to wit: "To approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils as hereinafter provided";

WHEREAS, the College Academic Council of the College of Education, Main Campus has reviewed and recommended to the University Academic Council for further refinement the conversion of the Bachelor of Science in Agricultural Development (BSc Ag. Dev.) to Bachelor of Science in Development Education (BSc Dev. Ed.) effective First Semester SY 2006-2007; and

WHEREAS, the University Academic Council (UAC) met on 03 March 2006 for the purpose of reviewing the proposal to convert the BSc Ag. Dev to BSc Dev. Ed. effective in the First Semester SY 2006-2007 and the UAC has recommended to the LSU Board of Regents the approval of the proposed conversion, *provided that* there will be at least 25 students who shall enroll in the new course.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the conversion of the Bachelor of Science in Agricultural Development (BSc Ag. Dev.) to Bachelor of Science in Development Education (BSc Dev. Ed.) effective First Semester SY 2006-2007 and provided that there are at least 25 students who will enroll in the course.
