BOR RESOLUTION NO. 198, s. 2018

A RESOLUTION APPROVING THE ISSUANCE OF THE NOTICE OF AWARD AND NOTICE TO PROCEED TO THE BNC CONSTRUCTION AND REPAIR SERVICES FOR THE CONSTRUCTION OF THE ROAD NETWORK WITH DRAINAGE SYSTEM, VSU TOLOSA, IN THE AMOUNT OF SEVEN MILLION FOUR HUNDRED FORTYNINE PESOS (P7,449,000.00) PER RECOMMENDATION OF THE VSU BIDS AND AWARDS COMMITTEE (BAC-1) RESOLUTION NO. 54 (INFRA-18-14) DATED 16 OCTOBER 2018

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, the Board of Regents approved the Budget of P9.90 million for the Construction of Road Network with Drainage System at VSU Tolosa, with the passage of BOR Resolution No. 164, s. 2018 on the occasion of the 86th BOR Meeting held last 04 October 2018 at the CHED Central Office, Pres. C.P. Garcia Avenue, UP Diliman, Diliman, Quezon City;

WHEREAS, the BAC-1 advertised the Invitation to Apply for Eligibility and to Bid in the PhilGEPS, VSU Website's Transparency Seal, and in conspicuous places within the premises of the Visayas State University for twenty-one (21) Calendar Days;

WHEREAS, in response to the BAC-1 advertisement, thirty (30) Contractors submitted Letters of Intent (LOI) but only seven (7) purchased bidding documents;

WHEREAS, the Bid Proposals submitted by the seven (7) Contractors were opened by the BAC-1 last 11 October 2018 and were all subjected to Preliminary Examination of Bids;

WHEREAS, the BAC, after checking the Technical documents of the seven (7) bidders using the Non-Discretionary Pass/Fail Criterion, passed six (6) bidders and failed one (1) bidder for not complying with the required Single Largest Completed Contract (SLCC);

WHEREAS, the financial proposals of the six (6) eligible bidders were opened by the BAC-1 and were then evaluated and ranked in accordance with the Lowest Calculated Bid (LCB);

WHEREAS, the BAC-1 conducted Post Qualification to verify and validate the truthfulness of the documents submitted by the Bidder with the LCB in its Technical Proposal as well as check the performance of the Bidder in some of the on-going and completed government and private contracts;

WHEREAS, the BAC-1 conducted a validation and verification of technical documents as well as checked the performance of the Bidder with the Lowest Calculated Bid;

WHEREAS, the BAC-1 determined that the Bidder with the Lowest Calculated Bid passed all the Post Qualification criteria;

WHEREAS, the BAC-1 declared that the Bid of <u>BNC Construction and Repair Services</u> in the amount of <u>Seven Million Four Hundred Forty-Nine Thousand PESOS (P7,449,000.00)</u> was the <u>Lowest Calculated and Responsive Bid (LCRB)</u>;

WHEREAS, the BAC-1 is recommending that the VSU Board of Regents approve the Notice of Award and Notice to Proceed for the *Construction of the Road Network with Drainage System at VSU Tolosa* to the <u>BNC Construction and Repair Services</u> in the amount of Seven Million Four Hundred Forty-Nine Thousand PESOS (P7,449,000.00) and Authorize the University President to sign the Notice of Award and Notice to Proceed on behalf of the VSU Board of Regents.

WHEREAS, the proposal was discussed and approved by the BOR Finance Committee during its Quarterly Meeting held last 23 November 2017 at the Samal Room, NEDA Regional Regional Office VIII, Government Center, Palo, Leyte;

WHEREAS, the BOR Finance Committee is strongly endorsing the proposal TO the VSU Board of Regents for Approval.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to Approve the Notice of Award and Notice to Proceed for the <u>Construction of the Road Network with Drainage System at VSU Tolosa</u> to the <u>BNC Construction and Repair Services</u> in the amount of Seven Million Four Hundred Forty-Nine Thousand PESOS (P7,449,000.00) and to Authorize the University President to sign the Notice of Award and Notice to Proceed on behalf of the VSU Board of Regents considering the Contract Amount is above P5.0 million limit of the President's "authority to approve" as specified in BOR Resolution No. 131, s. 2018 dated 03 September 2018.
