A RESOLUTION APPROVING THE COLLECTION OF TOUR GUIDE FEES FOR VISITORS OF THE LEYTE STATE UNIVERSITY

Dear Pres. Milan:

Thank you for your support that enabled the Office of the Vice President for Development and External Affairs (OVPDEA) through the Information Office and Alumni and Community Relations Office (ACRO) to establish and train a Pool of LSU Tour Guides to assist us in attending to our campus visitors. We can now provide better tour guiding services to our visitors and can therefore require fees for such services.

In view of this, we would like to propose visitors' fees for the following tour/ educational visit packages per vehicle:

Educational Packages	Fees
A. Campus tour; visit to University Library, Soil & Plant Analysis Lab., University Exhibits, Physical Education facilities, tissue culture lab	-campus maintenance fee (CMF)- P50 & tour fee (TF)- P150)
B. Package A sites plus visit to Natural History Museum	-CMF-P50,TF-P150, museum entrance- P5./head (40 x P5.=P200)
C. Campus tour, lecture-demo on plant propagation and other topics	-CMF-P50, TF-P150, lecture- demo- P150/topic
D. Nature Trek and Camping	Fees have already been determined by the Institute of Tropical Ecology

The fees shall be deposited in the LSU Cash Division and shall be issued appropriate receipts. As usual, the campus maintenance fee will be placed under the University's trust fund under the codename CMF 628 PICRO. A separate trust fund shall be opened for the tour fee (TF) and the accumulated amount shall be used in further enhancing tour guides' competence through training/ seminars/ field trip, purchase of uniforms and name tags, etc. The lecture-demo fees shall be placed under the trust funds of respective offices/ departments giving the lecture-demo.

May this proposal merit your appropriate action/ approval.
