## A RESOLUTION APPROVING THE ADOPTION OF CMO 30, s. 2004 REQUIRING THE SUBMISSION OF PORTFOLIO AS A REQUIREMENT IN PRACTICE TEACHING

**WHEREAS**, Section 4, Paragraph (j) of R.A. 8292 empowers the Governing Board "to set policies on admission and graduation of students";

WHEREAS, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: "It shall have the power to review and recommend the curricular offerings and rules of discipline of the university or college *subject to* appropriate action of the Board of Regents/Trustees. It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to* review and/or approval of the Board of Regents/Trustees through the President of the university or college";

**WHEREAS**, the Commission on Higher Education (CHED) issued CMO No. 30, s. 2004 requiring the submission of a Portfolio as a final requirement for Practice Teaching;

**WHEREAS**, the University Administrative Council (UADCO) is convinced that the submission of a Portfolio as a final requirement for Practice Teaching is required by CMO 30, s. 2004 and is necessary to enable the graduates to earn an additional five (5) points attendant to their application for teacher positions, thus would be advantageous to them;

**WHEREAS**, the UADCO, on the occasion of its 81<sup>st</sup> UADCO Meeting held last 15 February 2010 at the University Review Center, Center for Continuing Education, VSU, Visca, City of Baybay, Leyte, unanimously approved the request of the Dean of the College of Education, VSU Main Campus, for the immediate implementation requiring the submission of a Portfolio as a final requirement in Practice Teaching in accordance with CMO 30, s. 2004.
