BOR RESOLUTION NO. <u>69</u> Series of 2025

CONFIRMING THE AUTHORITY GRANTED BY THE UNIVERSITY PRESIDENT TO SELECTED FACULTY MEMBERS OF VISAYAS STATE UNIVERSITY TO PRACTICE THEIR PROFESSION **BEYOND OFFICE HOURS** 

WHEREAS, Section 7(b)(2) of Republic Act No. 6713, otherwise known as the Code of Conduct and Ethical Standards for Public Officials and Employees, allows public officials and employees to engage in the private practice of their profession during incumbency only when duly authorized and provided that such practice does not conflict with their official functions:

WHEREAS, Section 18, Rule XIII of the Omnibus Rules Implementing Book V of Executive Order No. 292, provides that public officers and employees may engage in private professional practice only with the written permission of the head of the agency and in accordance with Civil Service Commission rules and regulations;

WHEREAS, the University President, by virtue of the authority vested in the position, approved the requests of the following faculty members to engage in the limited and responsible practice of their profession beyond official working hours (i.e., on Saturdays, Sundays, holidays, and outside regular work schedules), ensuring that such activities do not interfere with their university functions:
