WHEREAS, Prof. Damiel M. Tudtud, Jr., Vice-President for Planning, Resource Generation and External Affairs, has been designated by the University President, Dr. Edgardo E. Tulin, to be the Officer-In-Charge of the Visayas State University for the duration of his travel to Kasesart University, Bangkok, Thailand from 29 January 2017 to 01 February 2017.

Patindol be designated as Officer-In-Charge of the University for the duration of the University President's travel to Bangkok, Thailand this coming 29 January 2017 to 01 February 2017 Subject to existing rules and regulations governing powers that may be exercised by an Officer-In-Charge.
