BOR RESOLUTION NO. 76, s. 2015

A RESOLUTION CONFIRMING THE RENEWAL OF APPOINTMENTS OF 91 ACADEMIC FACULTY, VSU SYSTEM, UNDER TEMPORARY STATUS SUBJECT TO EXISTING POLICIES, RULES AND GUIDELINES ON SUCH APPOINTMENTS EFFECTIVE ON THE DATES INDICATED

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, the Visayas State University needs to renew the contracts of qualified academic faculty to teach the different courses in the University;

WHEREAS, the College Deans through the Vice President for Academic Affairs have recommended the renewal of the selected temporary academic faculty;

WHEREAS, University Academic Personnel Board (APB) has gone over the qualifications of the appointees and the Human Resource Management Office (HRMO) has recommended to the University President the renewal of the appointments of the 91 academic faculty under Temporary Status.

WHEREAS, University President has reviewed the list forwarded by the HRMO and is favorably recommending to the Board of Regents the Confirmation of the renewal of appointments of these appointees *subject to* existing rules, regulations and guidelines governing such appointments.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to confirm the renewal of appointments of the aforementioned 91 academic faculty with temporary appointments effective on the dates indicated.
