## A RESOLUTION APPROVING THE PROJECTED INCOME AND PROPOSED EXPENDITURES OF THE VISAYAS STATE UNIVERSITY FOR CY 2008

**WHEREAS**, there is a need to augment GAA appropriations for the efficient and effective delivery of needed services to its clientele;

**WHEREAS,** the Visayas State University system reasonable expects to generate income from various sources for the period 01 January 2008 to 30 December 2008 in the amount of Sixty One Million Four Hundred Sixty Two Thousand Four Hundred pesos (P61,462,400.37);

**WHEREAS**, the VSU system expects to utilize this income attendant to its academic, extension, research and production functions, as follows: Forty Nine Million Three Hundred Sixty Two Thousand and Four Hundred pesos (P49,362,400.00) for General Expenditures and Twelve Million One Hundred Thousand pesos (12,100,000.00) for Fiduciary Expenditures;

WHEREAS, the Governing Board (GB) is authorized under R.A. 8292 to appropriate all sums as may be provided and authorize the disbursement of all income of the University provided that it is for the benefit of the institution;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the Projected Income and Proposed Expenditure of the VSU System, as proposed.
