## A RESOLUTION APPROVING THE PUBLICATION INCENTIVE SYSTEM FOR THE VSU SYSTEM

**WHEREAS**, one of the barometers of an academic institution's scientific productivity is the quantity and quality of publications of its faculty members publish;

**WHEREAS**, the Visayas State University is one of the acknowledged contributors of publication articles in per-reviewed publications;

**WHEREAS**, the University needs to encourage its academic faculty to publish their works whether creative or products of research in the form of papers, monographs, chapter(s) of books, or entire books in internationally respected publications that require peer-review and adhere to high standards of scholarship;

**WHEREAS**, the proposed Publication Incentive System is designed to encourage more VSU faculty members to publish their works;

**WHEREAS**, Section 7, Paragraph (b) of Republic Act No. 9158 empowers the Governing Board "to receive and appropriate all sums as may be provided, for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University";

**WHEREAS**, Section 10 of R.A. 9158 provides that the Administrative Council "...review and recommend to the Board (of Regents) policies governing the administration, management and development planning of the University"; and

**WHEREAS**, the University Administrative Council, on the occasion of its 85<sup>th</sup> UADCO Meeting held at the Office of the University President last 16 August 2010 approved the proposal and is recommending the approval of the proposal by the VSU Board of Regents.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the proposed publication incentive system for the VSU system, as proposed.
