**A RESOLUTION APPROVING THE
REQUEST OF DR. JOSE L. BACUSMO FOR
AUTHORITY TO TRAVEL TO YOGYAKARTA, INDONESIA
FROM 7-11 OCTOBER 2013 TO ATTEND THE APO WORKSHOP ON RAISING
PRODUCTIVITY IN HIGHER EDUCATION SPONSORED BY THE ASIAN
PRODUCTIVITY ORGANIZATION AND THE MINISTRY OF
MANPOWER AND TRANSMIGRATION,
REPUBLIC OF INDONESIA**

WHEREAS, Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, among the powers given to the VSU Board of Regents by virtue of RA 9158 includes the power *"To develop consortia and other forms of linkages with local government units, institutions and agencies, both public and private, local and foreign, in furtherance of the purposes and objectives of the University"*;

WHEREAS, the University President, Jose L. Bacusmo has been accepted to attend the APO Workshop on Raising Productivity in Higher Education (13-RP-08—GE-WSP-B) at Yogyakarta, Indonesia from 7-11 October 2013;

WHEREAS, this workshop is jointly sponsored by the Asian Productivity Organization (APO) and the Ministry of Manpower and Transmigration, Republic of Indonesia;

WHEREAS, the University President will be presenting a Country Paper in line with the guidelines to be provided by the APO, as stated in the Project Notification dated 28 March 2013, Item 15;

WHEREAS, the APO will provide the airline tickets to and from the venue;

WHEREAS, the mother agency will shoulder the pre-departure expenses and local travel to Manila and back to the agency;

WHEREAS, the University President is requesting that he be allowed to travel to Yogyakarta, Indonesia; and

WHEREAS, the University President would like to secure permission to utilize University Funds for pre-departure expenses as well as for his domestic travel, for this purpose.

NOW, THEREFOR, BE IT RESOLVED, AS IT IS HEREBY RESOLVED that Dr. Jose L. Bacusmo, be as he is, be permitted to travel to Yogyakarta, Indonesia from 7-11 October 2013 to attend the APO Workshop APO Workshop on Raising Productivity in Higher Education (13-RP-08—GE-WSP-B).
