BOR RESOLUTION NO. 48, s. 2014

A RESOLUTION CONFIRMING THE CHANGE IN APPOINTMENT STATUS OF FIVE (5) FACULTY OF VSU TOLOSA FROM CONTRACTUAL TO TEMPORARY SUBJECT TO EXISTING RULES, REGULATIONS AND GUIDELINES GOVERNING SUCH APPOINTMENTS AND EFFECTIVE ON THE DATES INDICATED

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University “*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*”;

WHEREAS, among other powers granted to the Board of Regents is the power “*to fix and adjust salaries of faculty members and administrative officials and employees subject to the provisions of the Revised Compensation and Position Classification System and other pertinent budget and compensation laws governing hours of service...*” as stipulated in Item (h), Section 7 of R.A. 9158;

WHEREAS, the Visayas State University has to constantly upgrade the employment status of its employees whenever regular plantilla items are available;

WHEREAS, the Academic Personnel Board, after careful deliberation, has determined that some academic personnel have been with VSU Tolosa for the past few years but without the needed degrees qualifications but now possess the minimum qualifications for the grant of plantilla items (*temporary status*) renewable every year in accordance with existing University policies and guidelines on the award of plantilla items to deserving academic staff, as follows:


