**A RESOLUTION CONFIRMING THE MEMORANDUM
OF AGREEMENT ENTERED INTO BY THE VSU, NEDA RO-8
AND THE STATISTICAL RESEARCH AND TRAINING CENTER**

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "*to develop consortia and other forms of linkages with local governments, institutions and agencies, both public and private, local and foreign, in furtherance of the purposes and objectives of the University*" as stipulated in Section 7, Item (s) of R.A. 9158;

WHEREAS, the Statistical Research and Training Center (STRC), an accredited government training institution wishes to conduct non-degree training programs to upgrade the quality of statistics personnel and expand the pool of statistical manpower in the Philippines;

WHEREAS, the National Economic and Development Authority (NEDA) through the NEDA Regional Office VIII also desires to accelerate the conduct of statistical trainings in the region to promote responsive and effective information-for-planning and decision-making requirements;


WHEREAS, the Visayas State University (VSU) has adequate information technology (IT) facilities as well as qualified manpower in the field of Statistics that will enable it to become an effective training partner/affiliate in the conduct of regional and local trainings;

WHEREAS, the Governing Board, is aware of the importance and necessity of conducting the project in order to prepare the LGUs and NGOs for statistical trainings for local development planning and decision-making.


