BOR RESOLUTION NO. 06, s. 2006

A RESOLUTION APPROVING THE GRANT OF PARITY RIGHTS AS FILIPINOS TO MR. GARRICK E. NEHLS AND MR. STEPHEN E. NEHLS

WHEREAS, the Leyte State University Board of Regents passed BOR Resolution No. 102, s. 2002 dated 08 November 2002 which provides for the assessment of fees for foreign students;

WHEREAS, the University Legal Counsel has opined that based on Article 4, Section 1, Paragraph 2 of the 1987 Constitution of the Philippines, Ms. Juliet Evardo Nehls, mother of the students in questions, has not renounced nor lost her Philippine citizenship at the time she gave birth to Garrick and Stephen and is still in fact a citizen of the Philippines as borne out by per latest Philippine passport (XBN-K548253) dated 25 May 1998 issued by the Philippine Embassy External Office in Berlin, Germany;

WHEREAS, the opinion of Mr. Reynaldo D. Rostata, Chief of the Bureau of Immigrations, Tacloban District Office R-8, Tacloban City, Leyte merely points out the way by which Garrick and Stephen may legally be clothed with Philippine citizenship;

WHEREAS, Ms. Juliet Evardo Nehls, is now presently and permanently living in Poblacion Talibon, Bohol, Philippines and is the sole supporter of her children's education at the Leyte State University;

WHEREAS, BOR Resolution No. 102, s. 2002 presumes that foreign students are supported with funds coming from foreign sources and such being the case, should be assessed differently from Filipino students considering that LSU is a government supported educational institution;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to grant Mr. Garrick E. Nehls and Mr. Stephen E. Nehls parity rights with Filipino students mainly on the consideration that their mother, a citizen of the Philippines, now lives permanently in the Philippines and is the sole bread winner of the family.
