**A RESOLUTION APPROVING
THE PROPOSED BREAKDOWN
OF FEES FOR THE BS NURSING PROGRAM**

WHEREAS, Leyte State University – Main Campus will be offering the ladderized BS Nursing program in the 1st Semester of SY 2007-2008;

WHEREAS, it is necessary to come up with the fees that will be charged to cover all the costs attendant to the offering of said course as it is treated as a Special Program of the University;

WHEREAS, other schools in the region offering BS Nursing charge between P18,000.00 to P32,000.00 per semester;

WHEREAS, LSU Administration has decided to levy a semestral fee of P15,000.00 per student to defray expenses for the new degree offering, broken down as follows:


Miscellaneous Fees	- P 2,000.00
Nursing Fee	- <u>13,000.00</u>


WHEREAS, the University Administrative Council during its 62nd Meeting held last 27 March 2007 has strongly recommended the approval of the said breakdown of fees for the ladderized BS Nursing Program.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposed breakdown of fees for the ladderized BS Nursing program, effective 1st Semester SY 2007-2008.
