#### BOR RESOLUTION NO. 28, s. 2018

A RESOLUTION APPROVING THE SABBATICAL LEAVE APPLICATION OF DR. LUCIA M. BORINES FOR THE PERIOD 01 AUGUST 2018 TO 31 JULY 2019 PROVIDED THAT THE SABBATICAL LEAVE GUIDELINES APPROVED BY THE VSU BOARD OF REGENTS ARE STRICTLY FOLLOWED

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Paragraph (h), Section 7 of RA 9158 provides, to wit: "... to grant them, at its discretion, leaves of absence under such regulations as it may promulgate, any provisions of existing law notwithstanding; ..."

WHEREAS, the faculty and staff of state universities and colleges belong to the "closed career positions of the Civil Service" being scientific or highly technical in nature and as such are mandated to establish and maintain its own merit system;

WHEREAS, sabbatical assignment is granted to qualified members of the faculty to encourage study, investigation, research and to improve staff competencies for improved efficiency;

WHEREAS, Dr.Lucia M. Borines, Professor IV, Visayas State University – Main Campus, has expressed her desire to avail of a one-year Sabbatical Leave starting 01 August 2018 to 31 July 2019;

WHEREAS, Dr. Borines has indicated that she would like to present the following outputs of his Sabbatical Leave, as follows

- a. At least two (2) published research articles as senior author, published in a peer reviewed reputable journal. A Certification from the Editor/s-In-Chief will be required to indicated that such papers have been accepted for publication, if the publication/s is/are not yet released;
- b. Prepare 2 Instructional Materials PPAT 215 (Advanced Phytobacteriology Expanded Syllabus) and PPAT 281 (Bacteriology in Plant Pathology Expanded syllabus) duly Certified by the Instructional Media Development Center (IMDC) as proof that such has been submitted for Review and Acceptance; and
- c. The Publication outputs should be products of her own research and not those derived from the theses of her students.

WHEREAS, Academic Personnel Board (APB), in its 25 January 2018 meeting recommended for Approval to the Board of Regents of the Sabbatical Leave application of Dr. Lucia M. Borines for the period 01 August 2018 to 31 July 2019; and
