**WHEREAS**, the University's Academic Personnel Board has determined that she now qualifies to be given a regular plantilla item;


**WHEREAS**, the Human Resource and Management Office is strongly recommending the change in status of appointment of the identified academic staff to the LSU Board of Regents;
