**BOR RESOLUTION NO. 12, s. 2013**

**PROPOSAL TO INCREASE THE RENTAL OF VSU HOSTEL'S  
SEASIDE COTTAGE NO. 2 FROM P700.00/NIGHT TO P1,500.00/NIGHT**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 4 of R.A. 9158 specifically provides that the University "*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*";

**WHEREAS**, among other powers granted to the Board of Regents is the power "*to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University*" as stipulated in Section 7, Paragraph (a) of R.A. 9158;

**WHEREAS**, the University maintains a substantial number of lodging infrastructure in the Main Campus that cater to short-term lodging of University guests, visitors and other clientele who find the University lodging facilities a better alternative to hotels in the area;

**WHEREAS**, the University Hostel has just completely renovated and expanded Hostel Seaside Cottage No. 2 and has installed air-conditioning and added a kitchen, a cable TV set, and a refrigerator to this facility to ensure a very satisfying and comfortable stay of University guests and visitors who may use this facility;

**WHEREAS**, the cost of maintaining these University facilities have been increasing on account of the skyrocketing prices of materials needed to maintain them;


**WHEREAS**, the University Administrative Council discussed and approved the proposed increase in the rate of Hostel Seaside Cottage No. 2 from P700/night to **P1,500/night** during the 100<sup>th</sup> Meeting held last 27 February 2013 at the 2<sup>nd</sup> Floor of the Center for Continuing Education, VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO has strongly endorsed the proposal to the VSU Board of Regents for Approval.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to Approve the proposal to increase the rate of Hostel Seaside Cottage No. 2 from P700/night to **P1,500/night**, as proposed, effective upon BOR approval.


