**A REFERENDUM ON THE
ADDITIONAL LIST OF CANDIDATES
FOR GRADUATION, 2nd SEMESTER, SY 2008-2009**

WHEREAS, Section 4, Paragraph (j) of R.A. 8292 empowers the Governing Board "to set policies on admission and graduation of students";

WHEREAS, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: "... It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to* review and/or approval of the Board of Regents/Trustees through the President of the university or college";

WHEREAS, Item c of Section 39 of CHED Memorandum No. 3, s. 2001 dated 21 January 2001 provides that the Academic Council: "Fix the requirements for the admission of students in the concerned chartered SUC as well as for their graduation and the conferment of degrees and submit the same to its GB for review and/or approval in accordance with Section 4, Paragraph (j) of R.A. 8292";

WHEREAS, the University Academic Council in a Special Meeting held at the University Convention Center dated 12 March 2009 has discussed the merits of the additional list of candidates for graduation, as follows:


WHEREAS, the University Academic Council during the Special Meeting decided that a Referendum be immediately routed.


