BOR RESOLUTION NO. 48, s. 2012

**A RESOLUTION APPROVING THE PROPOSAL TO INCREASE THE
REGISTRATION FEE FOR SUMMER RECREATIONAL ACTIVITIES OFFERED
BY THE INSTITUTE OF HUMAN KINETICS, VSU MAIN CAMPUS, SUBJECT TO
EXISTING GUIDELINES, RULES AND REGULATIONS ON THIS MATTER**

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*";

WHEREAS, among other powers granted to the Board of Regents is the power "*to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University*" as stipulated in Section 7, Paragraph (a) of R.A. 9158;

WHEREAS, the Institute of Human Kinetics at the Main Campus, has been providing a range of summer recreation activities since 1989 in response to requests from parents, employees and students for its offering with the objective of "*helping the participants develop leisure values and necessary skills to pursue optimum leisure lifestyles as well as foster positive attitudes towards life, work and leisure*";

WHEREAS, the cost of offering the different summer recreation activities which run for 24 contact-hours, has dramatically increased since it was first offered thus, necessitating a request for an increase in the fees charged from P500.00 per participant to P1,000.00 per participant starting in Summer 2013;




WHEREAS, the UADCO is strongly endorsing the proposal to the VSU Board of Regents for Approval.






