A RESOLUTION APPROVING THE DESIGNATION OF DR. REMBERTO A. PATINDOL, VP FOR INSTRUCTION AS OFFICER-IN-CHARGE OF THE UNIVERITY FOR THE DURATION OF THE PRESIDENT'S TRAVEL TO AUSTRALIA FROM 20 DECEMBER 2015 TO 07 JANUARY 2016 SUBJECT TO EXISTING RULES AND REGULATIONS GOVERNING POWERS THAT MAY BE EXERCISED BY AN OFFICER-IN-CHARGE

WHEREAS, President Edgardo E. Tulin has filed a leave-of –absence charged to his leave credits in the University for the duration of his travel to Australia;

WHEREAS, there is a need to designate an Officer-In-Charge (OIC) to look after the day-to-day operations including making routine but necessary decisions so as not to unduly delay any and all operations of the University; and

WHEREAS, Dr. Remberto A. Patindol, Vice-President for Instruction, has been designated by the University President, Dr. Edgardo E. Tulin, to be the Officer-In-Charge of the University for the duration of his travel to Australia from 20 Decembe 2015 until 07 January 2016 or until his return to the VSU Main Campus, City of Baybay, Leyte.

NOW, THEREFOR, BE IT RESOLVED, AS IT IS HEREBY RESOLVED that Dr. Remberto A. Patindol be designated as Officer-In-Charge of the University for the duration of the University President's travel to Australia this coming 20 December 2015 until 07 January 2016 or until his return *subject to* existing rules and regulations governing powers that may be exercised by an Officer-In-Charge.
