BOR RESOLUTION NO. 102, s. 2015

A RESOLUTION APPROVING THE PROPOSED ACADEMIC CALENDAR FOR SY 2016-2017 AND THE OFFERING OF A REMEDIAL SUMMER PROGRAM IN THE MONTHS OF JUNE-JULY 2016

WHEREAS, Section 7, Paragraph (a) of R.A. 9158 empowers the Governing Board "to enact rules and regulations as may be necessary to carry out the purposes and functions of the University";

WHEREAS, Section 10 of R.A. 9158 indicates that it is the duty of the Administrative Council "to review and recommend to the Board policies governing the administration, management and development planning of the University";

WHEREAS, the Governing Board (GB) passed BOR Resolution No. 09, s. 2014 dated 12 March 2014 which approved the Academic Calendar for SY 2015-2016;

WHEREAS, the GB passed BOR Resolution No. 69, s. 2015 dated 10 October 2015 which approved the shift in the opening of the SY 2016-2017 from June to August;

WHEREAS, the shift in the opening of classes in SY 2016-2017 from June to August necessarily creates a second summer session covering the months of June and July 2015;

WHEREAS, the second summer session will be used for holding a "remedial summer program" to give students a chance to take up subjects they need in their respective degree programs in order for them to become regular students again;

WHEREAS, the proposed SY 2016-2017 Academic Calendar and the offering of a remedial summer program for SY 2015-2016 in the months of June-July 2016, was discussed and approved by the University Administrative Council (UADCO) on the occasion of its 115th UADCO Meeting held last 21 November 2015 at the Conference Hall, Center for Continuing Education, VSU Main Campus, Visca, City of Baybay, Leyte and is strongly endorsing the same to the VSU Board of Regents for Approval.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to Approve the proposed SY 2016-2017 Academic Calendar and the offering of a remedial summer program for SY 2015-2016 in the months of June and July 2016, as presented.
