**A RESOLUTION APPROVING THE
TRANSFER OF DELOYMENT OF ONE (1)
ADMINISTRATIVE AIDE IV POSITION FROM VILLABA
CAMPUS TO THE MAIN CAMPUS *SUBJECT TO EXISTING RULES,*
REGULATIONS AND GUIDELINES GOVERNING SUCH TRANSFERS**

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "*exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines*";

WHEREAS, Par. 2.2 of Item 2.0, Section 2.0 of CMO No. 18, s. 1999 dated 01 June 1999 specified, to wit: "*Upon integration, the organizational structure and staffing pattern of the integrated CSIs shall be reviewed by the DBM with reference to the organizational structure and staffing pattern of the host SUC*";

WHEREAS, the plantilla item of Administrative Aide IV of the Villaba Campus has been left vacant for some time after its former incumbent employee retired from service in 2009;

WHEREAS, the Department of Budget and Management (DBM) no longer released the funds for the unfilled position since 20120;

WHEREAS, in order to fully maximize this plantilla item, the Non-Academic Personnel Board (NAPB), during its 07 July 2011 meeting, deemed it proper that this available plantilla item be given to a deserving Administrative Aide III employee from the Main Campus with the assurance to the Villaba Campus that the item will be replaced with a similar item with the anticipated vacancy this 07 July 2011 on account of the compulsory retirement of one employee;

WHEREAS, there is a need to swap plantilla items between the Main Campus and the External Campuses, and vice-versa, to be able to fill-up some of the vacant plantilla positions per advice from the DBM;

WHEREAS, the Office of the Director for Administration and Human Resources Development (ODA-HRD) and the University Non-Academic Personnel Board have strongly recommend the swapping of plantilla positions between the different campuses of the University System;


BOR Resolution No. 80, s. 2011 – A Resolution Approving the transfer of deployment of one (1) Administrative Aide IV Position from Villaba Campus to the Main Campus, Subject to existing Rules, Regulations and Guidelines governing such transfers.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the swapping of plantilla positions between the Villaba Campus and the Main Campus subject to existing rules, regulations and guidelines governing such transfers.


