**A RESOLUTION CONFIRMING THE
TENTATIVE LIST OF CANDIDATES FOR

WHEREAS, Section 11 of Republic Act No. 9158 – The Academic Council - stipulates the powers of the Academic Council to wit: “... *review and recommend curricular offerings and fix the requirements for the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval of the Board*...”;


WHEREAS, the University Academic Council has reviewed the prospective list of candidates for graduation with *Latin Honors* from the different campuses of the VSU System for the 2nd Semester, SY 2011-2012 on the occasion of its 30th University Academic Council meeting held at the University Convention Center last 27 February 2012; and

WHEREAS, the UAC is strongly endorsing the list of candidates for graduation with *Latin Honors* from the different campuses to the VSU Board of Regents for **Confirmation**, *Provided That*, all the candidates shall have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2011-2012.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to **Confirm** the prospective list of candidates for graduation with *Latin Honors* from the different campuses of the VSU System for the 2nd Semester, SY 2011-2012 *Provided That*, all the candidates shall have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2011-2012.
