**A RESOLUTION CONFIRMING THE NEW
APPOINTMENTS OF SOME CONTRACTUAL ACADEMIC

WHEREAS, the University President has approved the new appointments of the selected academic faculty charged to Lump Sum appropriation and is endorsing to the Board of Regents the Confirmation of said appointments subject to existing rules, regulations and guidelines governing such appointments.


