A RESOLUTION CONFIRMING THE CANDIDATES FOR GRADUATION OF THE MAIN CAMPUS AND THE EXTERNAL CAMPUSES FOR THE SUMMER SY 2008-2009

It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to* review and/or approval of the Board of Regents/Trustees through the President of the university or college";

WHEREAS, Item c of Section 39 of CHED Memorandum No. 3, s. 2001 dated 21 January 2001 stipulates, to wit: "Fix the requirements for the admission of students in the concerned chartered SUC as well as for their graduation and the conferment of degrees and submit the same to its GB for review and/or approval in accordance with Section 4, Paragraph (j) of R.A. 8292";

WHEREAS, the University Academic Council has reviewed the list of candidates for graduation for the Summer 2008-2009 by Referendum and has recommended the same to the VSU Board of Regents for Confirmation, *Provided*, That all the candidates have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for Summer SY 2008-2009.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the list of candidates for graduation from the Main Campus and External Campuses for the Summer SY 2008-2009 *Provided* That all the candidates have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2008-2009.
