**A RESOLUTION CONFIRMING THE CHANGE IN APPOINTMENT STATUS OF
ELEVEN (11) ACADEMIC FACULTY FROM TEMPORARY TO PERMANENT
SUBJECT TO EXISTING RULES, REGULATIONS AND GUIDELINES
GOVERNING SUCH APPOINTMENTS**

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University “*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*”;

WHEREAS, among other powers granted to the Board of Regents is the power “*to fix and adjust salaries of faculty members and administrative officials and employees ...*” as stipulated in Section 7, Item (h) of R.A. 9158;

WHEREAS, the Academic Personnel Board (APB) of the Visayas State University, undertook a process of screening the most qualifications of the candidates for permanency following the requirements set by the ViSCA Code and in the NBC 461 Guidelines;

WHEREAS, after due deliberation, the APB determined that the eleven (11) faculty members possess the necessary qualifications for permanency, as follows:




