**BOR Resolution No. 55, s. 2006**

**REQUEST OF DR. PACIENCIA P. MILAN  
FOR AUTHORITY TO TRAVEL TO THE  
ZHEJIANG GONGSHANG UNIVERSITY, CHINA**

**Whereas**, the Leyte State University (LSU) through its Vice President for Development and External Affairs, Dr. Manuel K. Palomar and the Zhejiang Gongshang University (ZJGSU) through its Vice Director of International Affairs, Prof. Wang Guo-An, have come to an agreement on the establishment of faculty/student cultural exchanges between the two Universities;

**Whereas**, the President of the Leyte State University (LSU), Dr. Paciencia P. Milan, has been invited to visit the Zhejiang Gongshang University (ZJGSU), Hangzhou Province, Peoples Republic of China (PROC) for five (5) days sometime in the last week of September 2006;

**Whereas**, a Memorandum of Agreement (MOA) between Zhejiang Gongshang University through its President, Dr. Hu Zuguang and the Leyte State University through its President, Dr. Paciencia P. Milan, will be signed during this visit;

**Whereas**, the international air fares to and from China of President Milan will be provided for by the Zhejiang Gongshang University including full board and lodging as well as all local transportation expenses during said official visit;

**Whereas**, the three (3) LSU Vice-Presidents have also been invited to this official visit of the LSU President provided that they shoulder their international air fares;

**Whereas**, the Leyte State University has been given a unique opportunity to establish another international academic and research linkage which is beneficial to the interests of LSU;


**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED** That Dr. Paciencia P. Milan, be as she is, be permitted to travel to the Zhejiang Gongshang University (ZJGSU), Hangzhou Province, Peoples Republic of China (PROC) for five (5) days sometime in the last week of September 2006.


