BOR RESOLUTION NO. 97, s. 2016

A RESOLUTION APPROVING THE UPGRADING OF POSITION OF DR. LILIBETH G. MIRALLES AND DR. OBDULIA G. CAMOYING TO THE POSITION OF PROFESSOR I SUBJECT TO GUIDELINES SET BY THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) AND EFFECTIVE ON THE DATE OF ISSUANCE OF ORIGINAL APPOINTMENT

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*";

WHEREAS, among other powers granted to the Board of Regents is the power "*to appoint, upon recommendation of the President, ... and other officials and employees of the University*" as stipulated in Section 7, Item (g) of R.A. 9158;

WHEREAS, the University regularly promotes academic staff whenever there are vacancies brought about by retirement of personnel;

WHEREAS, two (2) faculty members, Dr. Lilibeth G. Mirrales and Dr. Obdulia G. Camoying went through screening for Full-Professor;

WHEREAS, the Department of Budget and Management (DBM) provides for the upgrading of the qualified faculty members *provided that* they are endorsed by the governing Board;


WHEREAS, the Human Resource Management and Development Office and the University Academic Personnel Board strongly recommends the upgrading of Dr. Dr. Lilibeth G. Mirrales and Dr. Obdulia G. Camoying to the position of Professor I effective on the date of original appointment;


THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the promotions of the two (2) faculty members to Full-Professor I position, effective on the date indicated.
