### BOR RESOLUTION NO. 16, s. 2019

A RESOLUTION APPROVING THE REQUEST OF THE VSU TOLOSA FOR AUTHORITY TO CONDUCT A REVIEW CLASS FOR THE BACHELOR OF SCIENCE IN CRIMINOLOGY STARTING SY 2018-2019 AT Php 4,500.00 PER REVIEWEE

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

**WHEREAS**, among the other powers of the GB as provided for Section 7 (d) of R.A. 9158 stipulates, to wit: "to fix the tuition fees and other necessary school fees and charges, such as, but not limited to matriculation fees, graduation fees and laboratory fees, as it may deem proper and reasonable to impose after due consultations with the involved sectors…";

**WHEREAS**, the VSU Tolosa has thought of instituting a Review Class for the BS Criminology graduates to better prepare them for the Criminology Licensure Examination;

**WHEREAS**, the University Review Center (URC) in the VSU Main Campus does not offer Review Classes in Criminology;

**WHEREAS**, the URC has been implementing BOR Resolution No. 53, s. 2011 mandating the honoraria of URC reviewers to P350/hour;

**WHEREAS**, the VSU Tolosa is proposing that local reviewers be given an honorarium of P500/hour while the national reviewers be given an honorarium of P800/hour for the BS Criminology Review Class;

**WHEREAS**, the higher honoraria given to reviewers is in response to the high demand for Criminology Reviewers in and around Tacloban City;

WHEREAS, the proposal was discussed and approved by the University Administrative Council on the occasion of the 134<sup>th</sup> UADCO Meeting held last 26 February 2019 at 2/F, Center for Continuing Education Building, VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.
