BOR RESOLUTION NO. 17, s. 2023

A RESOLUTION APPROVING TO INCREASE GARBAGE COLLECTION RATE IN VISAYAS STATE UNIVERSITY FROM THIRTY PESOS (P30.00) PER MONTH TO ONE HUNDRED PESOS (100.00) PER MONTH AND THE REQUEST TO OUTSOURCE THE HAULING OF GARBAGE FROM VSU TO BAYBAY CITY DUMPSITE

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Directors of a corporation under Section 36 of Batas Pambansa Blg. 68 otherwise known as the Corporate Code of the Philippines";

WHEREAS, Paragraph (b), Section 7 of R.A. 9158 provides: "To receive and appropriate all sums as may be provided, for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University";

WHEREAS, VSU is a CHED Center for Excellence (COE) in Agriculture and a National University in Region VIII, it is mandated to provide leadership in developing highly competitive human resource, relevant scientific knowledge, and innovative technologies to support the sustainable development of the Visayas Region in particular and the whole of the Philippines in general;

WHEREAS, the proposal was based on RA 9003 that stipulated that open dumpsites should not be allowed as final disposal sites if an open dumpsite exist within the city or a municipality;

WHEREAS, the garbage disposal area within the VSU campus would not be allowed to be used anymore under the said law and that VSU would be required to dump its waste at the designated dumpsite of the City of Baybay;

WHEREAS, addressing solid waste and garbage disposal in the university had become more costly, hence, the need to increase garbage collection rate from P30.00 per month to P100.00 per month;

WHEREAS, with the proposal approved by the Board, it would be of great advantage to the university for there would be less garbage piles in the campus,

WHEREAS, in conjunction of the present proposal, the collection of segregated garbage would also be implemented;

WHEREAS, the proposal was discussed and endorsed by the University Administrative Council during its April 3, 2023 meeting to the VSU BOR Finance Committee

WHEREAS, the VSU BOR Finance Committee discussed the proposal and endorsed the same to the Full Board for approval during a hybrid committee meeting on 11 April 2023.

Resolved as it is thereby resolved to APPROVE to increase the garbage collection rate in Visayas State University from thirty pesos (P30.00) per month to one hundred pesos (P100.00) per month and the request to outsource the hauling of garbage from VSU to Baybay City dumpsite.
