# A RESOLUTION APPROVING THE INCREASE OF THE FINE FOR LATE REGISTRATION

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to approve the curricula, instructional programs and rules of discipline drawn by the administrative and academic councils, as herein provided" as stipulated in Item (i), Section 7 of R.A. 9158;

WHEREAS, the process of Student Registration is not complete until after the enrolment fee or the required down payment of school fees is paid;

WHEREAS, many students have been recalcitrant about following the prescribed Registration Schedules causing unnecessary delay in the preparation of the enrolment lists and other reports;

WHEREAS, there is a need to minimize the problem of delayed registration through the imposition of a stiffer penalty for late registration;

WHEREAS, the University Administrative Council unanimously approved the increase in the Late Registration Fine effective 2<sup>nd</sup> Semester, SY 2008-2009 during the 72<sup>nd</sup> UADCO Meeting held last 19 September at the 2<sup>nd</sup> Floor of the Center for Continuing Education, VSU Main Campus, Visca, City of Baybay, Leyte.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the the Late Registration Fine effective 2<sup>nd</sup> Semester, SY 2008-2009.

## Proposal to Increase the Fine for Late Registration

Registration is not complete until the enrolment fee or required down payment of school fees is paid. It has been observed many of our students mostly seniors do not enroll or do not complete the process of their enrolment on time in spite of the fine we imposed on them. The practice of students postponing their enrolment caused delay in the preparation of enrolment list and other reports especially class rosters to be given to the professors as soon as the start of classes.

To minimize this problem, it is proposed that we increase the fine for late registration.

Proposal:

Fine for late Registration

Existing

P50.00 for the first day and P10.00 per day thereafter Proposed

P50.00 for the first 5 days and P500.00 after the 5 day period
