### BOR RESOLUTION NO. 15, s. 2023

## A RESOLUTION APPROVING THE PROPOSAL TO PURCHASE SIX (6) UNITS OF MOTORCYCLES TO BE ASSIGNED AT THE GENERAL SERVICES OFFICES (GSO)

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS,** Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Directors of a corporation under Section 36 of Batas Pambansa Blg. 68 otherwise known as the Corporate Code of the Philippines";

**WHEREAS**, Paragraph (b), Section 7 of R.A. 9158 provides: "To receive and appropriate all sums as may be provided, for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University";

**WHEREAS,** VSU is a CHED Center for Excellence (COE) in Agriculture and a National University in Region VIII, it is mandated to provide leadership in developing highly competitive human resource, relevant scientific knowledge, and innovative technologies to support the sustainable development of the Visayas Region in particular and the whole of the Philippines in general;

**WHEREAS**, the essence of the proposal was to request for BOR to purchase of six units of motorcycles to be assigned at the General Services Office;

**WHEREAS**, that the total estimated price for the purchase of the motorcycles was four hundred eighty thousand pesos (480,000.00) charged to the Special Trust Fund of the University;

**WHEREAS**, the university's utility and messenger staff had been using their own motorcycles in the delivery of their duties and responsibilities because the university had no motorcycles of its own;

**WHEREAS,** VSU's area was very big and that the university could not allocate gasoline for private motorcycles promoting the utility and messenger workers to spend for gasoline using their own money;

**WHEREAS**, the approval of the proposal would increase the productivity and economy of the university's utility and messenger staff;

**WHEREAS,** the proposal was discussed and endorsed by the University Administrative Council during its March 23, 2023 meeting to the VSU BOR Finance Committee

**WHEREAS**, the VSU BOR Finance Committee discussed the proposal and endorsed the same to the Full Board for approval during a hybrid committee meeting on 11 April 2023.

Resolved as it is thereby resolved to APPROVE the Purchase Six (6) Units of Motorcycles to be Assigned at General Services Offices (GSO).
