**A RESOLUTION APPROVING THE  
PROPOSAL TO INSTITUTE AN ADDITIONAL  
COURSE AND CHANGE OF PREREQUISITE IN THE  
BS NURSING PROGRAM BASED ON CMO NO. 14, s. 2009  
EFFECTIVE 2<sup>nd</sup> SEMESTER, SY 2011-2012**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7, Paragraph (i) of R.A. 9158 empowers the Governing Board "to approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils, as hereby provided";

**WHEREAS**, Section 11 of Republic Act No. 9158 – The Academic Council - stipulates the powers of the Academic Council to wit: "The academic council shall have the power to review and recommend the curricular offerings and rules of discipline of the university or college subject to the appropriate action of the Board of Regents/Trustees. It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, subject to review and/or approval of the Board of Regents/Trustees through the President of the university or college";


**WHEREAS**, there is a need for the BS Nursing Program to "Institute an Additional Course and Change in Course Prerequisite in the BS Nursing Program" in order for it to be fully compliant with CMO No. 14, s. 2009; and




