**A RESOLUTION CONFIRMING
THE UPGRADING OF THE RANK OF
MS. AVELINA V. OCLINARIA FROM
INSTRUCTOR I TO INSTRUCTOR II BASED
ON NBC 461 4TH CYCLE EVALUATION RESULTS
SUBJECT TO GUIDELINES SET BY THE DEPARTMENT OF
BUDGET AND MANAGEMENT (DBM)**

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*";

WHEREAS, among other powers granted to the Board of Regents is the power "*to appoint, upon recommendation of the President, ... and other officials and employees of the University*" as stipulated in Section 7, Item (g) of R.A. 9158;

WHEREAS, the University regularly promotes academic staff whenever there are vacancies brought about by retirement of personnel;

WHEREAS, the aforementioned faculty member went through the 4th Cycle of NBC 461 and by virtue thereof, was able to qualify for the position of Instructor II;

WHEREAS, the Department of Budget and Management (DBM) provides for the upgrading of the qualified faculty member *provided that* she is endorsed by the Governing Board; and

WHEREAS, the Human Resource Development Office (HRDO) and the University Academic Personnel Board (APB) are strongly recommending her assumption to her new academic position.




