BOR RESOLUTION NO. 130, s. 2017

A RESOLUTION AMENDING BOR RESOLUTION NO. 84, s. 2017 "A RESOLUTION APPROVING THE PROPOSAL OF THE UNIVERSITY STUDENT SERVICES OFFICE (USSO) FOR THE COLLECTION OF FEES FOR PSYCHOLOGICAL AND NON-PSYCHOLOGICAL TESTS GIVEN TO CLERICAL AND SECURITY GUARD APPLICANTS"

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, the Governing Board passed BOR Resolution No. 84, s. 2017 on the occasion of the 79th BOR Meeting held at the CHED Central Office, C.P. Garcia Avenue, UP Diliman, Diliman, Quezon City last 23 October 2017;

WHEREAS, the University Student Services Office (USSO) has been tasked with the giving of psychological and non-psychological tests for all applicants to clerical as well as security guard positions;

WHEREAS, the Testing Materials used are "standardized test materials" purchased from the Philippine Psychological Corporation (PhilPsyCor);

WHEREAS, there is a need to recover all the cost associated with the purchase and administration of the Test Materials;

WHEREAS, there was a clerical error made on the entry for the "fee to be collected from Security Guards for the 16 PF test" which should have been P100.00 and not P50.00; and

WHEREAS, the proposal was discussed by the University Administrative Council (UADCO) on the occasion of the 127th UADCO Meeting held last 24 November 2017 at the 1/F, Conference Room, Office of the Vice President for Administration and Finance, VSU Main Campus, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the Amendment of BOR Resolution No. 84, s. 2017, effective upon BOR Approval.
