BOR RESOLUTION NO. 68, s. 2009

APPROVING THE APPOINTMENT TO REGULAR POSITIONS OF SOME ADMINISTRATIVE STAFF

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to fix and adjust salaries of faculty members and administrative officials and employees ..." as stipulated in Section 7, Item (h) of R.A. 9158;

WHEREAS, the University regularly provides regular plantilla items to its administrative employees whenever there are available;

WHEREAS, the Non-Academic Personnel Board, after careful deliberation, has determined that Mr. Remegio M. Sanico and Mr. Jimmy O. Pugosa possess the qualifications for the assumption of the regular plantilla item position in accordance with existing University policies and guidelines;

WHEREAS, the Human Resource Management and Development Office and the University Non-Academic Personnel Board strongly recommend the giving of the regular plantilla item of Administrative Assistant II to Mr. Remegio M. Sanico and the regular plantilla item of Farm Worker II to Mr. Jimmy O. Pugosa, effective on the dates indicated.

WHEREAS, the Governing Board, is convinced that the recommendations of the NAPB is fair and adheres to thrust of government that only the best and the most fit should be in the government service;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the regularization of Mr. Remegio M. Sanico (Administrative Assistant II) and Mr. Jimmy O. Pugosa (Farm Worker II), effective on the dates indicated.
