BOR RESOLUTION NO. 21, s. 2010

A RESOLUTION CONFIRMING THE MEMORANDUM OF AGREEMENT (MOA) ENTERED INTO BY THE VISAYAS STATE UNIVERSITY (VSU) WITH OUTSIDE ENTITIES

WHEREAS, the Visayas State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to develop consortia and other forms of linkages with local government units, institutions and agencies, both public and private, local and foreign, in furtherance of the purposes and objectives of the University" as stipulated in Item (s), Section 7 of R.A. 9158;

WHEREAS, the Board of Regents approved BOR Resolution No. 14, s. 2006 dated 21 February 2006 authorizing the University President "to approve and sign agreements with other institutions, local and foreign, for joint academic, research and/or training programs, provided that such agreements do not involve any additional and/or special budgetary outlay on the part of the University and has been reviewed by the University Legal Counsel and concerned officials, and provided further that all such agreements are submitted to the Board of Regents for Confirmation."

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to confirm the Memorandum of Agreement (MOA) between the Visayas State University and the various agencies and entities.
