# A RESOLUTION AMENDING BOR RESOLUTION NO. 34, s. 2011 DATED 11 MARCH 2011 AND APPROVING THE BUDGET FOR THE EVALUATION COMMITTEE FOR THE VSU PRESIDENCY

**WHEREAS**, the term of Dr. Jose L. Bacusmo as University President of the Visayas State University is set to expire on 31 October 2011;

**WHEREAS**, under Section 9 of R.A. 9158 provides, to wit: "The University shall be headed by a president who shall render full-time services. He shall be appointed by the Board upon the recommendation of a duly constituted search committee. He shall hold office for a term of four (4) years, extendible only for another four (4) years";

WHEREAS, President Bacusmo has expressed to the Board of Regents his desire to seek reappointment for another term as University President on the occasion of the 50<sup>th</sup> BOR Meeting held at the Leyte Normal University Conference Room, Tacloban City last 11 March 2011;

**WHEREAS**, the VSU Board of Regents originally passed BOR Resolution No. 34, s. 2011 dated 11 March 2011 on the occasion of the 50<sup>th</sup> BOR Meeting which pegged the Budget for the Evaluation Committee to P100,000.00, to wit:
