## BOR RESOLUTION NO. 43, s. 2008

## A RESOLUTIONAPPROVING THE COLLECTION OF P100.00 AS COMPUTER LABORATORY FEE, P100.00 AS CICT ACCESS FEE AND P100.00 AS CONVENTION CENTER USAGE FEE

WHEREAS, the Visayas State University Laboratory High School (VSU-LHS) management has now implemented computer literacy starting at the First Year level and therefore needs to start collecting a laboratory fee of P100.00 which is the same fee as what is collected in the higher year levels;

WHEREAS, the VSU-LHS has also provided its students with broadband internet access as a tool for scientific learning especially on its impact on student research and that this service has to be sustained considering its positive and beneficial effects on the students enabling a VSU-LHS student to copping the INTEL-Philippines top award in science and becoming one of the Philippines representative to the INTEL-USA competition last May 2008;

WHEREAS, in consideration of the provision of broadband access service to VSU-LHS students, a CICT fee of P100.00 is likewise requested for collection from all students at all year levels, as a means of sustaining said internet access service;

WHEREAS, the VSU-LHS regularly conducts a number of activities at the VSU Convention Center, and that collections have to be made from the students to defray expenses attendant to the said activities and this is tedious and unnecessarily puts pressure on the class treasurers who are tasked with the collection of such moneys;

WHEREAS, the VSU-LHS management has calculated that the advance collection of P100.00 will be sufficient to defray expenses attendant to the use of the VSU Convention Center for the different activities of the Laboratory High School; and

**WHEREAS**, the University Administrative Council (UAdCo) on the occasion of its 71<sup>st</sup> Meeting dated 27 May 2008 took up, approved and recommended to the Board of Regents the approval of this proposal.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the collection of P100.00 as Computer Laboratory Fee, P100.00 as CICT Access Fee; and P100.00 as Convention Center Usage Fee, as proposed, effective 1st Semester SY 2008-2009.
