APPROVING THE DESIGNATION OF PROF. DANIEL M. TUdTUD, JR.,
VICE PRESIDENT FOR PLANNING, RESOURCE GENERATION AND EXTERNAL
AFFAIRS AS OFFICER-IN-CHARGE OF THE UNIVERSITY FOR THE DURATION OF
PRESIDENT EDGARDO E. TULIN'S TRAVEL TO PHNOM PENG, CAMBODIA FOR
THE PERIOD 20 APRIL 2016 TO 23 APRIL 2016 OR UNTIL PRESIDENT TULIN'S
RETURN *SUBJECT TO* EXISTING RULES AND REGULATIONS GOVERNING
POWERS THAT MAY BE EXERCISED BY AN OFFICER-IN-CHARGE**

WHEREAS, the Philippine Embassy in Cambodia and the Commission on Higher Education (CHED) has organized the 1st Philippine Education Fair in Phnom Penh, Cambodia this coming 22 April 2016 to 23 April 2016;

WHEREAS, the CHED will be sending an official delegation composed of representatives of selected Higher Education Institutions (HEIs) and CHED officials;

WHEREAS, VSU President Edgardo E. Tulin has been invited to be part of the CHED delegation to attend and participate in the Education Fair as well as engage in sideline meetings with potential partner institutions in Cambodia;

WHEREAS, there is a need to designate an Officer-In-Charge (OIC) to look after the day-to-day operations including making routine but necessary decisions so as not to unduly delay any and all operations of the University; and

WHEREAS, Prof. Daniel M. Tudit, Jr. Vice-President for Planning, Resource Generation and External Affairs has been designated by the University President, Dr. Edgardo E. Tulin, to be the Officer-In-Charge of the University for the duration of his travel to Cambodia from 20 April 2016 until 23 April 2016 or until his return to the VSU Main Campus, City of Baybay, Leyte.

NOW, THEREFOR, BE IT RESOLVED, AS IT IS HEREBY RESOLVED that Prof. Daniel M. Tudit, Jr. be designated as Officer-In-Charge of the University for the duration of the University President's travel to Cambodia this coming 20 April 2016 until 23 January 2016 or until his return *subject to* existing rules and regulations governing powers that may be exercised by an Officer-In-Charge.
