BOR RESOLUTION NO. <u>66</u> Series of 2025

CONFIRMING THE AUTHORITY TO TRAVEL ABROAD ISSUED BY THE UNIVERSITY PRESIDENT TO TWENTY-TWO (22) FACULTY AND STAFF FOR PURPOSES OF TRAINING, SCHOLARSHIP, CONFERENCE PARTICIPATION, BENCHMARKING, AND OTHER OFFICIAL FUNCTIONS, COVERING THE PERIOD JANUARY TO MARCH 2025.

WHEREAS, under Republic Act No. 8292, Section 4, and CHED Memorandum Order No. 7, s. 2022, the Governing Board is vested with the authority to promulgate rules on the governance of the university, including policies on official travel;

WHEREAS, BOR Resolution No. 92, series of 2024 and BOR Resolution No. 121, series of 2024, delegated to the University President the authority to approve and issue travel authorities abroad to qualified faculty and staff, in support of career development and capacity-building programs of the University;

WHEREAS, such foreign travel is essential to the effective administration of the University's academic, research, extension, and administrative affairs and aligns with the University's Learning and Development (L&D) Plan;

WHEREAS, from January to March 2025, the University President approved and issued twenty-two (22) travel authorities for official overseas travel involving participation in training programs, scholarships, fellowships, conferences, workshops, benchmarking, sabbatical leave, and other development-related activities, the details of which are reflected in the attached matrix;

WHEREAS, as a matter of policy, all delegated issuances are required to be submitted to the Board for confirmation;

WHEREAS, the University Administrative Council (UADCO), in its meeting held on February 14, 2025 at the RDE Hall, endorsed the confirmation of said travel authorities;

NOW, THEREFORE, on motion, duly seconded, and unanimously approved, be it;

RESOLVED, as it is hereby resolved, that the Board of Regents of Visayas State University confirms the twenty-two (22) travel authorities abroad issued by the University President for the period January to March 2025, as detailed in the attached matrix;
