BOR RESOLUTION NO. 02, s. 2024

A RESOLUTION COURSED THROUGH REFERENDUM APPROVING THE FINAL LIST OF THE CANDIDATES FOR GRADUATION OF THE VSU SYSTEM FOR THE FIRST SEMESTER OF ACADEMIC YEAR 2023-2024

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Directors of a corporation under Section 36 of Batas Pambansa Blg. 68 otherwise known as the Corporate Code of the Philippines";

WHEREAS, VSU is a CHED Center for Excellence (COE) in Agriculture and a National University in Region VIII, it is mandated to provide leadership in developing highly competitive human resource, relevant scientific knowledge, and innovative technologies to support the sustainable development of the Visayas Region in particular and the whole of the Philippines in general;

WHEREAS, a total of one hundred nineteen (119) students from the VSU System have satisfactorily complied with the requirements for Graduation for the First Semester of Academic Year 2023-2024;

WHEREAS, a total of seventy-nine (79) candidates for graduation from the undergraduate degree programs of the VSU Main Campus, one (1) from the VSU Isabel Campus, one (1) from the VSU Tolosa Campus, and twenty-two (22) from the VSU Alangalang Campus;

WHEREAS, a total of sixteen (16) graduate students have complied with the requirements for graduation from the university's different graduate degree programs;

WHEREAS, the list of the candidates for graduation were deliberated and approved by the University Academic Council during its meeting on 02 February 2024 at the VSU RDE Hall & endorsed by the BOR Academic & Administrative Committee during its meeting on the 17th of January 2024;

Resolved as it is thereby resolved to APPROVE the Final List of the Candidates for Graduation of the VSU System for the First Semester of Academic Year 2023-2024.
