## BOR RESOLUTION NO. 119, s. 2022

## A RESOLUTION APPROVING THE RELEASE OF ADMISSION FEE AND FIRST SEMESTER SY 2022-2023 BILLING RELATED TO THE "FOR LATER RELEASE (FLR)" AS PART OF THE GAA UNDER THE PROGRAM IMPLEMENTATION OF FREE HIGHER EDUCATION

**WHEREAS,** Republic Act 9158 converted the then Visayas State College of Agriculture (ViSCA) into a state university, the Leyte State University, on 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS,** Section 7, Paragraph (b) of R.A. 9158 empowers the Governing Board "to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University";

WHEREAS, VSU has requested for BOR Approval on the release of the admission fee and first semester SY 2022-2023 billing related to the For Later Release (FLR) as part of the General Appropriations Act (GAA) under the program Implementation of Free Higher Education;

**WHEREAS**, the total amount of Seventy Seven Million Two Hundred Twenty Six Thousand Seven Hundred Fifteen Pesos (P77, 226,715.00) for the whole VSU system is allocated where the first semester billing composed of 14,446 enrollees corresponds to the amount of P75,388,515.00 while the admission fee composed of 9,191 takers corresponds to the amount of P1,838,200.00;

WHEREAS, the details for the first semester billing are allocated to different items such as tuition fee corresponds to P39,655, 490.00, NSTP Fee is P734,040, Athletic Fee is P4,320,900.00, Computer Fee is P1,858, 806.00, Cultural Fee is allocated P1,008,210.00, P4,096,976.00 goes to Development Fees, P402,800.00 is allocated to Entrance/Admission Fees, P749,130.00 is allocated to Guidance Fees, Handbook Fees' allocation is P402,8003.00, P14, 670, 340.00 is allocated to Laboratory Fees, Medical and Dental Fees is allocated P2,878, 183.00, P2,083,850.00 is allocated to Registration Fees while School ID Fees is allocated P402,900.00 with the sum total allocated funds of P75, 388, 515.00;

**WHEREAS,** the proposal was discussed and endorsed by the University Administrative Council to the VSU BOR Finance Committee during its 13 January 2023 meeting at the VSU Board Room;

**WHEREAS**, the proposal was discussed and endorsed by the VSU BOR Finance Committee to the Full Board for approval during its 20 January 2023 meeting via zoom.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the release of Admission Fee and First Semester SY 2022-2023 billing related to the "For Later Release (FLR)" as part of the GAA under the Program Implementation of Free Higher Education.
