BOR RESOLUTION NO. 27, s. 2006

A RESOLUTION CONFIRMING THE LIST OF CANDIDATES FOR GRADUATION with HONORS OF THE TOLOSA CAMPUS FOR SCHOOL YEAR 2005-2006

WHEREAS, Section 4, Paragraph (j) of R.A. 8292 empowers the Governing Board "to set policies on admission and graduation of students";

WHEREAS, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: "... It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to* review and/or approval of the Board of Regents/Trustees through the President of the university or college";

WHEREAS, Item c of Section 39 of CHED Memorandum No. 3, s. 2001 dated 21 January 2001 stipulates, to wit: "Fix the requirements for the admission of students in the concerned chartered SUC as well as for their graduation and the conferment of degrees and submit the same to its GB for review and/or approval in accordance with Section 4, Paragraph (j) of R.A. 8292";

WHEREAS, the College Academic Council of the Tolosa Campus has reviewed and recommended the list of candidates for graduation *with* Honors for the Second Semester SY 2005-2006 to the University Academic Council for further refinement; and

WHEREAS, the University Academic Council met on 03 March 2006 for the purpose of reviewing the list of candidates for graduation with Honors of all colleges for the Second Semester of SY 2005-2006 and have found the list to be in order and have recommended to the LSU Board of Regents the list of candidates of graduation with Honors for approval, provided that the candidates shall have complied with all the requirements for graduation on or before the deadline as indicated in the approved Academic Calendar for School Year 2005-2006.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the list of candidates for graduation *with* Honors of the College of Fisheries, LSU Tolosa Campus, for the Second Semester of School Year 2005-2006 *provided that* the candidates shall have complied with all the requirements for graduation on or before the deadline as indicated in the approved Academic Calendar for School Year 2005-2006.
