BOR RESOLUTION NO. 3, s. 2007

A RESOLUTION CONFIRMING THE LIST OF CANDIDATES FOR GRADUATION OF THE COLLEGE OF ENVIRONMENTAL AND AGRICULTURAL TECHNOLOGY LSU-ALANGALANG CAMPUS, FOR THE 2ND SEMESTER, SY 2006-2007

WHEREAS, Section 4, Paragraph (j) of R.A. 8292 empowers the Governing Board "to set policies on admission and graduation of students";

WHEREAS, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: "... It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to* review and/or approval of the Board of Regents/Trustees through the President of the university or college";

WHEREAS, Item c of Section 39 of CHED Memorandum No. 3, s. 2001 dated 21 January 2001 stipulates, to wit: "Fix the requirements for the admission of students in the concerned chartered SUC as well as for their graduation and the conferment of degrees and submit the same to its GB for review and/or approval in accordance with Section 4, Paragraph (j) of R.A. 8292";

WHEREAS, the College Academic Council of the LSU-Alangalang Campus has reviewed and recommended the lists of candidates for graduation for the 2nd Semester SY 2006-2007 to the University Academic Council for further refinement; and

WHEREAS, the University Academic Council met on 06 February 2007 for the purpose of reviewing the list of candidates for graduation of the College of Environmental and Agricultural Technology for the 2nd Semester SY 2006-2007 and has found the list of candidates for graduation to be in order and has recommended the list of candidates for graduation to the LSU Board of Regents **for approval**, *provided that* the candidates shall have complied with all the requirements for graduation on or before the deadline as indicated in the approved Academic Calendar for School Year 2006-2007.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the list of candidates for graduation for the College of Environmental and Agricultural Technology, LSU-Alangalang Campus for the 2nd Semester SY 2006-2007 *provided that* the candidates shall have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2006-2007.
