BOR RESOLUTION NO. 53, s. 2014

A RESOLUTION CONFIRMING THE RENEWAL OF APPOINTMENT OF 108 ACADEMIC STAFF WITH TEMPORARY APPOINTMENTS WITHIN THE VSU SYSTEM EFFECTIVE ON THE DATES INDICATED *SUBJECT TO* EXISTING POLICIES, RULES AND GUIDELINES ON SUCH APPOINTMENTS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University “*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*”;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power “*to appoint, upon the recommendation of the President of the University ... faculty members and other officials and employees of the University.*” as stipulated in Section 7, Item (g) of R.A. 9158;

WHEREAS, the Visayas State University needs to renew the contracts of qualified academic faculty to teach the different courses in the University;

WHEREAS, the College Deans through the Vice President for Academic Affairs have recommended the renewal of the selected temporary academic faculty;

WHEREAS, University Academic Personnel Board (APB) has gone over the qualifications of the appointees and the Human Resource Management Office (HRMO) has recommended to the University President the renewal of following academic faculty with Temporary appointments:




