**A RESOLUTION

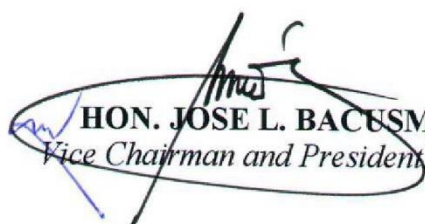

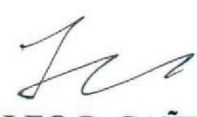

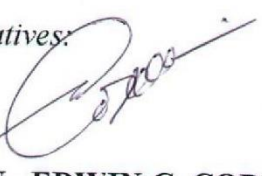
