**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) AND

THE LEYTE STATE UNIVERSITY (LSU) AND THE LANDBANK OF THE
PHILIPPINES FOR THE USE OF LANDBANK'S ATM PAYROLL
SYSTEM AND THE INSTALLATION OF AN OFFSITE ATM
MACHINE WITHIN LSU PREMISES**

WHEREAS, the Leyte State University desires to avail of the Landbank's ATM Payroll System;

WHEREAS, the Landbank is willing to extend said ATM Payroll System to the Leyte State University, subject to such terms and conditions as may be mutually agreed upon;

WHEREAS, the Leyte State University is also requesting that an offsite ATM unit be installed at its premises to serve the needs of the Leyte State University;

WHEREAS, the Landbank is willing to install an offsite ATM unit at the premises of the Leyte State University;

NOW, THEREFORE, be it resolved as it is hereby resolved that the Board of Regents of the Leyte State University hereby approves the signing of a MEMORANDUM OF AGREEMENT (MOA) between the Leyte State University and the Landbank of the Philippines covering the Terms and Conditions for the utilization of Landbank's ATM Payroll System and the installation of an offsite ATM machine within the premises of the Leyte State University – Main Campus, Visca, Baybay, Leyte;

RESOLVED FURTHER, that the LSU Board of Regents approves the Supplemental MEMORANDUM OF AGREEMENT entered into by the Leyte State University and the Landbank of the Philippines.
