BOR RESOLUTION NO. 64, s. 2019

A RESOLUTION, COURSED THROUGH REFERENDUM, CONFIRMING THE CANDIDATES FOR GRADUATION WITH LATIN HONORS, VSU SYSTEM, FOR THE 2nd SEMESTER, SY 2018-2019, PROVIDED THAT, ALL THE CANDIDATES HAVE COMPLIED WITH ALL THE REQUIREMENTS FOR GRADUATION ON OR BEFORE THE DEADLINE INDICATED IN THE APPROVED ACADEMIC CALENDAR FOR SCHOOL YEAR 2018-2019

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7, Paragraph (j) of R.A. 9158 empowers the Governing Board "to set policies on admission and graduation of students";

WHEREAS, Section 11 of Republic Act No. 9158 – The Academic Council - stipulates the powers of the Academic Council to wit: "... review and recommend curricular offerings and fix the requirements for the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval of the Board...";

WHEREAS, the list of candidates for graduation from the different campuses of the VSU System for the 2nd Semester, SY 2018-2019 was presented to the University Academic Council on the occasion of its 45th UAC Meeting held at the Center for Continuing Education, VSU Main Campus, Visca, City of Baybay, Leyte last 16 May 2019, for review;

WHEREAS, the University Academic Council reviewed the list of candidates for graduation with *Latin Honors* for the 2nd Semester SY 2018-2019 and have found the list of candidates for graduation with *Latin Honors* to be in order and has recommended to the VSU Board of Regents the list for *Confirmation*, *provided that* the candidates shall have complied with all the requirements for *Latin Honors* on or before the deadline indicated in the approved Academic Calendar for School Year 2018-2019.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to *Confirm* the list of candidates for graduation for *Latin Honors* for the 2nd Semester, SY 2018-2019 provided that the candidates shall have complied with all the requirements for *Latin Honors* on or before the deadline indicated in the approved Academic Calendar for School Year 2018-2019.
